MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding ("MOU") is executed on this 08th day of June, 2011 between:

Infotech Enterprises Limited represented by its **President – Global H. R & Corporate Affairs, Mr. B. Ashok Reddy**, having its registered office at Plot No. 11, Software Units Layout, Infocity, Madhapur, Hyderabad 500081, Andhra Pradesh, India, hereinafter called **Party – I**

and

Jawaharlal Nehru Technological University, Kakinada represented by its **Registrar, Prof. V. Ravindra**, KAKINADA 533003, A. P. hereinafter called **Party - II**

The parties hereby agree on mutual cooperation for setting up and running a Master of Technology Program in Avionics

Responsibilities of Party- I

1. To extend support and co operation for establishing and running of the M Tech program in Avionics at the Campus of party II
2. To provide industrial exposure to the students of M.Tech - Avionics by way of Internships/Project Works/Industrial Visits etc to the extent of feasibility and availability.
3. To provide Industry orientation / Practical Training in Avionics domain to the Faculty members of M.Tech - Avionics with mutual agreement of both the parties.
4. To nominate experts to deliver special lectures to the students of M Tech Avionics on mutual agreement of both parties
5. To undertake the absorption of M.Tech Avionics students to the extent of availability subject to meeting the selection standards.
6. To undertake joint R&D and consultancy projects with the Faculty members of party II and involvement of specialists at National and International Level whenever possible.
7. To undertake the Identification of the development projects, fixation of time frame and allocation of resources including financial to the extent of feasibility.



8. To allow access to designated staff and students of party II to visit the premises of party I in connection with industry orientation for the program.
9. To provide financial grant for the M Tech Avionics program based on the need from time to time.

Responsibilities of Party –II

1. To grant recognition to the M Tech Avionics program as a regular full time two year (four semester) post graduate course in engineering curriculum of the University .
2. To incorporate on mutual agreement the suggestions made by Party I in the curriculum of the M Tech Avionics programs.
3. To work out the financial aspects of the program jointly with party –I.
4. To assign the students, staff and faculty for any of the mutually agreed joint projects.
5. To provide the required support for Survey, design, testing and methods of evaluation for the mutually agreed projects.
6. To offer special lectures and training programs for the benefit of the staff and Graduate Engineers of Party I on mutually agreed terms.

Joint Responsibilities:

1. Areas of cooperation / collaboration will be identified jointly.
2. The syllabus and design of the M Tech Avionics course will be finalized in consultation between both parties.
3. For each area of cooperation specific projects will also be identified. The project title and the scope of work will be discussed and decided between both the coordinators and a preliminary project report indicating the scope, resources, facilities, test and evaluation, etc., will be prepared and signed by both the parties.
4. Both the parties agree to maintain confidentiality of information and the release of any information will be with mutual agreement of both parties.
5. Neither party shall have any liability except what is expressly mentioned herein.



6. While undertaking a joint project the expertise, software, hardware, data, etc available with either party will be made available for completion of the project
7. This agreement can be terminated with consent of the either party with three month prior notice and written information without any liability on each other.
