The respective Universities must extend the affiliation to such of those colleges which has complied with E-attendance. (i.e. The staff and students should register in Vidyawaan and attendance should be through E-attendance only)The affiliation status of the colleges will be uploaded on the website. The Universities may be directed to extend necessary support & information for successful implementation of E-attendance.

Further, the Universities and Colleges are informed that only those colleges which have implementing the Bio metric attendance system will be listed in the counselling, for admissions into UG & PG Programmes.

NIC Hyderabad has sent a proposal for implementation of Aadhar Based Biometric Attendance System. It has requested the requirement of 4 IT Professionals for which APSCHE has to pay salaries. In this connection, it is submitted for orders that NIC may be permitted initially to hire 2 IT Professionals for one year so as to implement the project successfully. The salary expenditure shall be met from ASPCHE funds.
