In partial modification of UGC letter of even number dated 1<sup>st</sup> April, 2009 on the subject cited above, I am directed to say you that the Jawahar Lal Nehru Technological University, Kakinada has been established by State Legislature (Act No. 30 of 2008 dated 24<sup>th</sup> September, 2008) and is empowered to award degrees on its main campus as specified by UGC under Section 22 of UGC Act, 1956 with the approval of Statutory Councils, wherever required.

The university is not allowed to start any off campus/ study centre beyond the territorial jurisdiction of the state in the light of the judgement of Hon'ble Supreme court of India in the case of Chhattisgarh Vs. Prof. Yashpal
